In the appeal, appellant has requested to hear him in person. ## Brief facts of the case:-

In the RTI application, the appellant has sought 3 points information in respect of Commission's decision dated 17.07.2017 and 31.07.2017.

## Decision with reasons:-

- 2. From the perusal of the appeal, it is observed that the appellant is not aggrieved with the reply of the CPIO, CIC but he is aggrieved with the wrong and irrelevant information allegedly provided by the respondent CPIO. Since appellant is not aggrieved with the information furnished by the CPIO, CIC, no action is required on the part of the FAA, in the matter.
- The appeal is, therefore, disposed off.
- 4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
