Brief facts of the case:-

In the RTI application, the appellant has sought following information in respect of his complaint dated 26.05.2017 addressed to Registrar, CIC against the CPIO. Northern Coalfields Limited, Singrauli (MP):-

- "1. Provide certified copy of comments made/action taken by the Registrar (addressee) or any competent authority of CIC on receipt of above referred 3 page complaint against the CPIO of Northern Coalfields Limited, Singrauli (MP).
- Provide certified copy of comments if any obtained/received from the CPIO of Northern Coalfields Limited, Singrauli (MP) in terms of action if any taken by the Registrar (addressee) or any competent authority of CIC on receipt of above referred 3 page complaint against the CPIO of Northern Coalfields Limited, Singrauli (MP)."
- 2. Shri R.P. Grover, CPIO cum DO to IC(YA) vide letter dated 12.04.2018 sent 13 copies of the letters received from the respondent in the appeal file no.CIC/NCFLT/ C/2017/138301 to the appellant.

In the appeal, the appellant has stated that the CPIO, Shri Grover provided 13 pages undesired and mis-matched information on payment. The acclaimed furnished information is simply in response to 2nd appeal filed online vide 60083 dated 06.12.2016 in continuity to request acknowledge as 565 by CPIO, NCL with furnishing of information as confirmed at 6 on annexed page no.7 and rest 3 pages from CPIO, CIL on transfer u/s 6(3).

The CPIO, NCL nowhere has hinted on either receipt of any communication from the Registrar (addressee) or any competent authority of CIC or submission of response thereof in respect of 3 page of complaint against CPIO, NCL matter central to request dated 16.02.2018. The so acclaimed furnishing of desired information by Shri R.P. Grover is wrong or he simply denied desired information. Hence, the CPIO may be directed to furnish information as sought in the RTI application.

Decision with reasons:-

- 3. From the above, it is observed that although the CPIO has sent the information as available on record with him but he has not furnished 2 points specific information sought in the RTI application. Direction is accordingly given to Shri R.P. Grover, CPIO & DO to IC(YA) to provide information on 2 points sought in the RTI application to the appellant within 1 week from the date of receipt of the order.
- 4. The appeal is, therefore, disposed off.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
