The appellant has sent the photocopy of his RTI application dated 22.12.2017 mentioning address of the AS/FAA, CIC without date on the body of RTI application requesting therein to order CPIO to provide information as sought, therefore, we mistook it and file it as miscellaneous matter. The I/c Dak Section vide remarks dated 08.05.2018 has stated that as per Dak Management System, there is no entry of letter dated 22.12.2017 of Shri Hukam Raj Badala.
