## Brief facts of the case:-

In the appeal, appellant has stated that even after one and a half months periods, he has not received any information against his RTI application dated 24.03.2018 and requested to provide the same.

## Decision with reasons:-

- 2. On perusal of the case file, it is observed that Shri Krishan Avtar Talwar, DS & CPIO to CR-1 vide letter No.CICOM/R/2018/00335/CR-1 dated 12.04.2018 has furnished the information. A copy of the letter dated 12.04.2018 is enclosed.
- 3. In his reply dated 12.01.2018, Shri Talwar has stated that:-

"Though the Computerized Dak Management System of the Commission reflects transfers of Dy.No.177039 dated 03.10.2016 to Central Registry, despite of vigorous efforts, it is not traceable. It seems it might have been mixed up with misc. papers during transfer of Central Registry or during its renovation. Efforts are still on to trace it.

You may, however, in the meanwhile like to provide a duly signed copy of said communications along with self attested copy of all relevant enclosures, as per Rule 8 of RTI Rules 2012 by name to undersigned, so that action on the same may be taken."
