## Brief facts of the case:-

In the appeal, appellant has stated that the CPIO neither responded to his RTI application of dated 19.03.2018 nor given any decision on the request within 30 days from receipt of the application i.e. by 22<sup>nd</sup> April, 2018 in the referred case shall be deemed to have refused the request.

## Decision with reasons:-

2. On perusal of the AppsCom software, it is revealed that the said RTI application was diarized in the Commission vide Dy. No.118944 dated 23.03.2018 and sent to Compliance Cell as link paper to case file No.CIC/YA/A/2015/002653. Further on perusal of the copy of RTI application enclosed with the appeal, it is observed that the appellant has clearly mentioned in the subject "Application under RTI Acti 2005" and also mentioned the IPO No.43F 228602 dated 01.01.18 for Rs.10/- as enclosure. Hence, it is not understood how the said RTI application has been treated as link paper and sent to Compliance Cell? Shri Krishan Avtar Talwar, CPIO & DS to CR-I is hereby directed to enquire into the matter and submit fact finding report within 15 days from the date of receipt of the order to the undersigned.

- 3. A copy of the RTI application dated 19.03.2018 as found enclosed with the appeal is forwarded to Shri Ashok Kumar Sharma, CPIO, RTI Cell with the direction to register the same and seek information from the concerned CPIO u/s 5(4) and provide information to the appellant within 2 weeks from the date of receipt of this order.
- 4. The appeal is, therefore; disposed off accordingly.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
