Brief facts of the case:-

In the RTI application, appellant has sought 8 points information relating to cancellation of Legal Consultant (on contractual basis) exam conducted by Central Information Commission on 10.02 2018 at ISTM, New Delhi.

- 2. Mrs. Savita Taluja, SO(Admn) & CPIO vide letter dated 01.05.2018 furnished point-wise information
- In the appeal, appellant has stated that CPIO has provided incomplete information on Point (f) of the RTI application. On Point (f), appellant sought cutoff marks for the post of Legal Consultant for which exam was conducted by the Commission. The appellant alleged that instead of providing cut off marks, CPIO has supplied a copy of notice, which is not the complete information, sought by the applicant.

Decision with reasons:-

On perusal of reply furnished by the CPIO on Point (f) and copy of the notice dated 06.02.2018 enclosed with the reply, it is observed that at SI.No.5, it is clearly mentioned that "Maximum number of candidates to be shortlisted in written exam - 200 subject to cut off 50 per cent of total marks." Therefore, there is no infirmity in the reply of the CPIO since the information sought has been furnished to the appellant.

- The appeal is, therefore, disposed off accordingly. 4.
- In case the appellant is aggrieved by the decision, he is free to file second 5. appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
