Brief facts of the case:-


In the RTI application, appellant has sought copy of replies from all CPIOs in compliance to Commission's decision in File No.CIC/NDMCN/A/2016/307548 dated 23.08.2017. Shri R.P. Grover, CPIO & DO to IC(YA) vide letter dated 17.05.2018 has intimated that reply has been received from South Delhi Municipal Corporation EE(B) Hqr, Minto Road, New Delhi vide diary No.176779 dated 16.11.2017 containing 8 pages and demanded further fee of Rs.16/- from the appellant.

2. In the appeal, the appellant has stated that besides the CPIO of South Delhi Municipal Corporation, compliance of the order had been sought from several other CPIOs as well, which the CPIO's reply doesn't mention. The appellant has also requested for inspection of the case file.

Decision with reasons:-

3. In view of the above, direction is given to Shri R.P. Grover, CPIO & DO to IC(YA) to offer inspection of the concerned case file to the appellant with mutual convenient date & time and appellant shall be allowed to take copies of the desired documents after collecting from him the requisite fee under the RTI Act and the Rules.
