**Brief facts of the case:-**

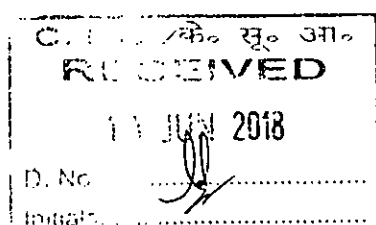
In the appeal, appellant has stated that:-

*".....DO to IC(YA) & CPIO failed to dispose of RTI application within 30 days of receipt of RTI application as prescribed u/s 7(1) of RTI Act 2005."*

*Appellant is not satisfied on the conduct of DO to IC(YA) & CPIO in dealing RTI application and prefer appeal in this case and urge for your prompt and appropriate decision."*

**Decision with reasons:-**

2. On perusal of the case file, it is observed that the RTI application was received in the RTI Cell on 23.04.2018 and CPIO, RTI Cell has transferred it to DO to IC(YA) vide letter dated 25.04.2018. The DO to IC(YA) received it on 26.04.2018 and furnished information to the appellant vide letter dated 23.05.2018. Hence, the CPIO cum DO to IC(YA) has furnished the information before the completion of prescribed 30 days period u/s 7(1) of the RTI Act, 2005.


