## Brief facts of the case:-

In the RTI application, appellant has stated as under:-

"Please refer to yours reply dated 21/03/18, vide no.CICOM/R/2018/00274, in which yours good self has forward to concerned CPIO(s) for sending reply but no such reply has been received inspite of the direction. Therefore kindly look into the matter and do the needful and information may please be supplied as early as possible of my original application."

2. Shri H.P. Sen, CPIO & DO to IC(DP) vide letter dated 11.05.2018 has responded as under:-

"This has reference to your above RTI application dated 05.05.2018. No information can be supplied to you as you have not sought any information under Section 2(f) of RTI Act 2005. However, in such cases non-compliance application should be filed as per the provision of the RTI Act"

## Decision with reasons:-

3. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that reply furnished by the CPIO is appropriate. It seems that respondent CPIO has not complied with the Commission order or provided incomplete information, therefore, appellant is advised to file a non-compliance case against the respondent CPIO in the Commission, separately.
