**Brief facts of the case:-**

In the appeal, appellant has stated that the CPIO has denied the opportunity to inspect the record as sought by him in the RTI application dated 05.05.2018.

**Decision with reasons:-**

2. On perusal of the AppsCom software, it is revealed that the said RTI application was diarized in the Commission vide Dy. No.129053 dated 05.05.2018 and it has been linked to case file No.CIC/SCOFI/A/2018/127937. Since the RTI application linked to the above mentioned case file inadvertently by the Compliance Cell, information sought could not be furnished to the appellant. **Shri Krishan Avtar Talwar, DS to CR-II is advised to brief the concerned persons, in this regard, so that such mistake may not occur in future.**

A copy of the RTI application as found enclosed with the appeal is forwarded to **Shri Ashok Kumar Sharma, CPIO, RTI Cell** with the direction to register the same and forward it to the concerned CPIO for providing information as sought in the RTI application to the appellant within 2 weeks from the date of receipt of this order.


