**Brief facts of the case:-**

In the RTI application, appellant has sought following information relating to Appeal No.CIC/SM/A/2011/000652/SG decided on 21.09.2011 vide Decision No.CIC/SM/A/000652/SG/14722 dated 21.09.2011:-

- (1) Documents annexed by me with the RTI application submitted to the PIO, UCObANK, ZO, Chandigarh (Copies RTI Application, First Appeal & Second Appeal are not required).
- (2) Documents submitted by the PIO, UCObANK, Zonal Office, Chandigarh in compliance of the Decision dated 21.09.2011 in Decision No.CIC/SM/A/2011/000652/14722.
- (3) Copy of the FIR, if any, lodged by the PIO, UCObANK, ZO, Chandigarh as directed by the CIC, New Delhi.
- (4) Copy of the action taken by the CIC, New Delhi due to non-compliance of the Decision under reference."

2. Shri S.S. Rohilla, CPIO & DO to IC(SB) vide reply dated 12.07.2018 has stated that "Copy of the second appeal in file no.CIC/SM/A/2011/000652 requested by the appellant originated from the appellant himself, he is not within his right to seek the same. In this connection, your attention is drawn to paragraph 6 and 7 of the Commission's order dated 05.12.2006 passed in file No.CIC/AT/A/2006/00411 in the case of G.P.S. Rana Vs Delhi Police...."

**Decision with reasons:-**

3. On perusal of the RTI application, CPIO's reply and submissions made in the appeal, it is observed that though the FAA is in agreement with the reply of the CPIO, however, the appellant has mentioned in the RTI application that he has lost all his records during transit from Kalka to Amravati due to illness. The plea mentioned by the appellant seems to be genuine, therefore, direction is given to Shri S.S. Rohilla, CPIO & DO to IC(SB) to provide copies of the documents as sought in the RTI application, as a special case, to the appellant within 2 weeks from the date of receipt of the order.

4. The appeal is, therefore, disposed off accordingly.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
