**Brief facts of the case:-**

In the RTI application, appellant has sought 6 points information in respect of Commission's order No.CIC/RM/A/2014/004572-SA dated 21.04.2016 and No.CIC/RM/A/ 2014/004572-MP dated 02.01.2018:-

2. Shri K.L. Das, CPIO & DO to IC(BJ) vide letter dated 27.04.2018 furnished following information:-

- "1. A copy of Show-Cause Notice dated 09.11.2017 is enclosed.*
- 2. A copy of reply No.f-14-5/117/2014/NIOS/Pers. Dated 21.11.2017 received from Sh. Sunil Kaura, Jt. Commissioner (Admn)/FAA is enclosed.*
- 3&4. Not available in the file, number and date be given to locate the reference.*
- 5. Case has been disposed by the Commission – the undersigned has no comments in this regard.*
- 6. A copy of the letter is enclosed."*

**Decision with reasons:-**

3. As per appeal, appellant is aggrieved that information on Points 3 & 4 has not been provided by the CPIO. On perusal of the CPIO's reply on Point 3 & 4, he stated that *"Not available in the file, number and date be given to locate the reference."* Further, Shri K.L. Das, CPIO & DO to IC(BJ) has been called for who informed that he supplied the factual information on the basis of soft copy of concerned case file available in the AppsCom software of the Commission. If appellant is not satisfied, he may inspect soft copy of the said case file.


