**Decision with reasons:-**

On perusal of the appeal, it is observed that the appellant wants to know the likely date of hearing of his case file No.CIC/CGDAC/A/2017/165049. In response to the RTI application dated 08.11.2017, Shri H.P. Sen, CPIO & DO to IC(DP) vide letter dated 28.11.2017 has informed that appellant that:-

*"....your application has been registered with CIC only on September 15. Hearing date will be fixed when your turn comes. A notice will be communicated to you after fixing the date."*


