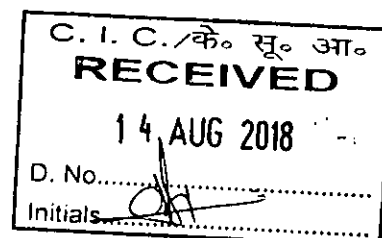

**Decision with reasons:-**

On perusal of the RTI application, reply of the CPIO and appeal, it is observed that appellant's 2<sup>nd</sup> appeal diarized vide Dy.No.122432 dated 11.04.2018 was returned to the appellant for removal of deficiency vide FM dated 11.04.2018. The appellant has re-submitted all documents (total 21 nos.) through speed post No.EM046096155IN dated 24.04.2018 and wanted to know the status of the same in the RTI application. Direction is accordingly given to Shri Krishan Avtar Talwar, CPIO & DR to CR-I to re-visit the RTI application and provide status of the 2<sup>nd</sup> appeal sent vide above mentioned speed post to the appellant within 2 weeks from the date of receipt of the order. All the documents enclosed with the appeal are enclosed herewith for r/r of the CPIO.

2. The appeal is, therefore, disposed off accordingly. Two IPOs bearing No.33F 588422 and 33F 588824 for Rs.10/- each are returned herewith, as no fee is required for filing appeal in the Commission.


