Dy. Secretary, Cabinet Secretariat vide letter dated 13.07.2018 had forwarded present first appeal to Department of Posts and Shri K.R. Sharma, Director(PG), Department of Posts, Dak Bhavan, New Delhi has forwarded the same to this Commission vide letter No.101-6/2013-RTI dated 26.07.2018 and accordingly it has been registered as first appeal.

Brief facts of the case:-

In the RTI application, appellant has sought information regarding action taken on his non-compliance petition dated 27.11.2017 relating to case File No.CIC/POSTS/A/2017/ 110809.

2. Shri T.K. Mohapatra, CPIO & DO to IC(SA) vide letter dated 23.05.2018 has furnished following information:-

"In your RTI application you have sought information regarding your letter dated 27-11-2017 stated to be a non-compliance application in respect of order dated 25-08-2017 in case file no.CIC/POSTS/A/2017/110809.

Since, there is no direction(s) to the Public Authority in the above said order, there is no compliance is required by the Public Authority, hence, the letter has been filed in the concerned case file without any specific action, as per records available in the e-book of the file."

Decision with reasons:-

3. On perusal of the RTI application, CPIO's reply and submissions made in the appeal, it is observed that information furnished by the CPIO is appropriate and factual, therefore, no intervention is required on the part of the FAA, in the matter.
