Brief facts of the case:-

In the RTI application, appellant has sought following information:-

"1. Details (Letter No., date of letter, originated from which section in CIC, subject matter, date of dispatch, by what post (Regd or Speed etc.), of letters sent from CIC, New Delhi to the following persons – from 18 August to 31st March 2009

Director, Shri K N Kittur – PIO&InfoDocumOfficer, Shri B K Mohanty-PIO & Stores Officer, Shri S.N. Rout, Asst. Prof. (Prosth & Orthotics) Dept. of P&O, Shri Ranjan Das – all of Swami Vivekanand National Institute of Rehabilitation Training and Research (SVNIRTAR), Olatpur, PO: Bairoi, Dist: Cuttak, Orissa 754010.

2. Details (Letter No., date of letter, subject matter, date of receipt at CIC, by what post (Regd. or Speed), forwarded to which section in CIC etc.) of letters received at CIC, New Delhi from the following persons from 18 August to 31st March 2009 –

Director, Shri K N Kittur&InfoDocumOfficer, PIO, Shri B K Mohanty-PIO & Stores Officer, Shri S.N. Rout, Asst. Prof.(Prosth & Orthotics) Dept. of P&O, Shri Ranjan Das, Accounts Officer – all of Swami Vivekanand National Institute of Rehabilitation Training and Research (SVNIRTAR), Olatpur, PO: Bairoi, Dist: Cuttack, Orissa 754010 from 18 August to 31st March 2009."

2. Shri Krishan Avtar Talwar, CPIO & DR to CR-I vide letter dated 13.08.2018 has sent following reply of Assistant, Dak Section:-

P.T.O.

".....regarding details of letters sent to and from Central Information Commission New Delhi by Shri K N Kittur & others during the period 18 Aug 2008 to 31st March 2009, however it could not be figured out from the available record. As such, we may request the applicant to inspect the available record for the aforementioned period within a month as record is to be weeded out as per record retention schedule."

3. In the appeal, appellant has stated that the sought information/documents were created at CIC and held at CIC and are required for convincing the CIC officials to solve the confusion created by CIC letter asking penalty amount of Rs.25000/- to be recovered from the appellant and requested to provide sought information and also instruct Dak Section not to weed out the records of this period till this case is finalized.

Decision with reasons:-

4. From the perusal of the above, it is observed that the statement of the deemed CPIO that it could not be figured out from the available record and requested appellant to inspect the available record is not understood. Hence, **direction is given to Shri Krishan Avtar Talwar, CPIO cum DR to CR-II to request the deemed CPIO to make a thorough search and provide information accordingly to the appellant within 2 weeks from the date of receipt of this order.**

5. The appeal is, therefore, disposed off accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
