**Brief facts of the case:-**

In the RTI application, appellant has sought following information:-

*"Certified copies of the application bearing Diary No.137904 dated 14-06-2018 and Diary No 138295 dated 18-06-2018 be provided along with action taken report on the same, as the said information is required to be submitted before the Hon'ble High Court of Punjab and Haryana at Chandigarh."*

2. Shri H.P. Sen, CPIO & DO to IC(DP) vide letter dated 18.07.2018 has furnished following information:-

*".....it may be mentioned that no action has been taken on your applications bearing Dy.No.137904 and Dy.No.138295 dated June 14 and 18, 2018 respectively. Since the documents sought are your own documents and are supposed to be available with you, therefore, certified copies of the same can not be provided to you."*

**Decision with reasons:-**

3. As per appeal, appellant is aggrieved that he had filed an application dated 11.06.2018, diarized in the Commission vide Dy.No.137904 dated 14.06.2018 in connection with non-compliance of the Commission's Order No.CIC/LS/C/2012/000745-AB heard on 05.05.2016 but instead of placing said application before the Hon'ble

P.T.O.

Commissioner, CPIO dealt the said application at his own level. Hence, appellant requested to put up his application before the Commission for taking appropriate action. The appellant also quoted paras of the above mentioned Commission's order and in the last para of the order, Commission states that:-

*"The respondent CPIO is directed to provide the above stated information within four weeks from the date of receipt of this order. Further action as deemed fit will be taken after receipt of the report from the CPIO."*

4. The matter was enquired with Shri H.P. Sen, CPIO & DO to IC(DP) who informed that he has provided information as per record available in the concerned case file. However, he was not aware of the decision given in the Commission's order No.CIC/LS/C/2012/000745-AB. In this regard, Shri H.P. Sen, CPIO & DO to IC(DP) is advised to do the needful as per decision of Hon'ble Information Commissioner and intimate the same to the appellant accordingly.

5. The appeal is, therefore, disposed off accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
