The matter was discussed with the Hon'ble Chief I.C. and it was directed that no further action is required. Accordingly, no action has been taken on your above letters."

## Decision with reasons:-

- 3. On perusal of the RTI application, CPIO's reply and submissions made in the appeal, it is observed that factual information has been provided by the CPIO, therefore, no intervention is required on the part of the FAA, in the matter.
