Brief facts of the case:-

In the RTI application, appellant has sought 13 points information in respect of 04 letters sent by CCSNIAM, Jaipur to CIC.

2. Shri K.A. Talwar, DS & CPIO(CR II) vide reply dated 01.08.2018 informed that all four communications received in the Commission were linked with the case file No.CIC/AD/A/2013/001326 and forwarded the RTI application to DO to IC(AB) for providing information.

3. In the appeal, appellant has stated that he did not get any reply in the letter of Shri K.A. Talwar, CPIO (CR II).

Decision with reasons:-

4. On perusal of the case file of RTI Cell and on enquiry from Shri Talwar, it is observed that Shri A.K. Talapatra, DO to IC(AB) further transferred the RTI application to Shri R.P. Grover, CPIO & DO to IC(YA) on 06.08.2018 as the public authority "DTC" under Govt. of NCT of Delhi is allocated to the registry of IC(YA). As per case file of RTI



Cell, Shri R.P. Grover has not furnished information to the appellant till date. Therefore, **direction is given to Shri R.P. Grover, CPIO & DO to IC(YA) to provide information as sought in the RTI application to the appellant within 1 week from the date of receipt of the order.**

5. The appeal is, therefore, disposed off accordingly.


6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.


