## Brief facts of the case:-

In the RTI application, appellant has sought present status of his application dated 01.11.2017 forwarded to the Secretary, West Bengal Information Commission vide Facilitation Memo No.175871/2017 dated 15.11.2017.

2. Shri Krishan Avtar Talwar, CPIO & DS to CR-I vide reply dated 30.07.2018 stated that:

".....your petition dated 01.11.2017 was forwarded vide Facilitation Memo dated 15.11.2017 to West Bengal Information Commission vide Speed Post Tracking No.ED621594796IN dated 20.11.2017 while endorsing a copy to you vide Speed Post Tracking No.ED621594513IN dated 20.11.2017.

Since the matter was found to be beyond the jurisdiction of this Commission accordingly it was forwarded to the concerned State Information Commission. As such, no action is pending on the part of this Commission on said Dy.No.175871/2017."

3. In the appeal, appellant has stated that ".... as to why no action on the content of my application is taken as yet."

## Decision with reasons:-

- 4. Since the CPIO has forwarded appellant's petition dated 01.11.2017 to the Secretary, West Bengal Information Commission for taking necessary action, appellant is advised to make further correspondence with the West Bengal Information Commission, in this regard.
- 5. The appeal is, therefore, disposed off accordingly.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
