**Brief facts of the case:-**

In the RTI application, appellant has sought 06 points information in connection with DoPT letter No.1/6/2011-IR dated 15<sup>th</sup> April, 2013 related to Prime Minister Office, Election Commission of India, Reserved Bank of India and Comptroller and Auditor General of India.

3. On the grounds of appeal, appellant stated that "No reply furnished by the CPIO" and requested to direct CPIO to furnish the information sought.

**Decision with reasons:-**

On perusal of the case file of RTI Cell, it is observed that Shri Kishore Kumar Pukhral, CPIO(Legal Cell) has furnished point-wise information to the appellant vide letter No.CIC/Legal/RTI/2018/001 dated 20.07.2018. Appellant might not have received the same, therefore, a copy of CPIO's reply is enclosed herewith.

5. It is further to mention that point-wise factual information has been provided by the CPIO, therefore, no further intervention is required on the part of the FAA, in the matter.



6. The appeal is, therefore, disposed off accordingly.



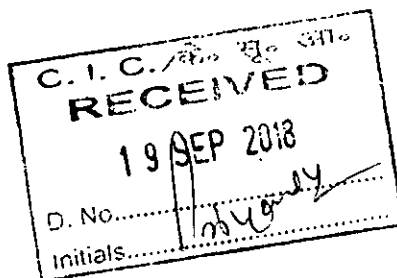

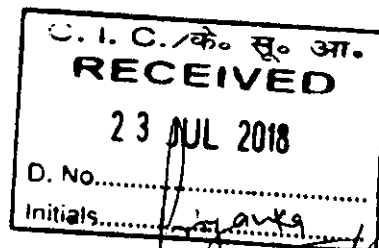
