## Brief facts of the case:-

In the RTI application, appellant has sought 08 points information in connection with action taken/compliance of DoPT letter No.1/6/2011-IR dated 15<sup>th</sup> April, 2013.

2. On the grounds of appeal, appellant stated that "No reply furnished by the CPIO" and requested to direct CPIO to furnish the information sought.

## Decision with reasons:-

- 3. On perusal of the appeal, it is observed that the appellant has filed appeal in respect of the public authority Department of Personnel & Training (DoPT) though in the RTI application, he has sought information concerning to Central Information Commission as a public authority. Therefore no action is required on the appeal.
- 4. Further, the appellant alleged that no reply has been furnished by the CPIO but on perusal of the case file, it is observed that Shri Kishore Kumar Pukhral, CPIO, Legal Cell has already furnished information vide letter No.CIC/Legal/RTI/2018/001 dated 20.07.2018 (copy enclosed) to the appellant.
- 5. It is also observed that point-wise information furnished by the CPIO is factual, therefore, no further intervention is required on the part of the FAA, in the matter.
