Appellant was present. Shri Sushil Kumar, DS(Admn) cum CPIO and Shri Jeewan Chandra, Consultant/CPIO(MR) were present.

## Decision with reasons:-

- During the hearing, appellant has stated that he is aggrieved with the response of the CPIO on Point (B) of the RTI application. On Point (B), two information were sought i.e. (i) list of officers who are exempted from recording their attendance in the biometric system and (ii) copy of the relevant orders. But the CPIO has provided information on part (i) only, which is incorrect and misleading information thereby wrongly denying the information to the appellant. The CPIO should have either give the list of officers who are exempted from recording their attendance or clearly state that no officer is exempted. On part (ii), CPIO has not provided any information.
- 3. In view of the above, direction is given to Shri Sushil Kumar, DS(Admn) & CPIO to re-visit Point (B) of the RTI application and provide appropriate information to the appellant within 1 week from the date of receipt of the order.

- 4. The appeal is, therefore, disposed off accordingly.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
