Brief facts of the case:-

In the RTI application, appellant has sought action taken report on his review petitions and its reminders in respect of Commission's Order No.CIC/CAGIN/2017/120936 dated 28.07.2017 and No.CIC/CAGIN/2017/120403 dated 28.07.2017 and video recordings of the entire hearing proceedings of both cases.

2. Shri S.C. Sharma, CPIO & DO to Chief IC vide letter dated 26.09.2018 has furnished following information:-

- "1. The video recording of hearing proceedings is not done by the Commission and hence no information is available.
2. Copies of your review petitions and reminders as indicated in your aforesaid RTI seems to have not been received in this Registry and therefore no action has been taken. Even otherwise, it is pertinent to mention that there is no provision under RTI Act, 2005 to review its own decisions delivered by the Commission. Hence decisions already delivered in appeal No.CIC/CAGIN/A/2017/120936 and appeal No.CIC/CAGIN/A/2017/121403 (correct file No. is 121403 and not 120403, both heard on 28.07.2017) cannot be reviewed."


Decision with reasons:-
