## Brief facts of the case:-

In the RTI application, appellant has sought following information:-

- "1. What is the status of my letters to CIC vide your diary Nos. (a) 162154/ 05-9-17 and (b) 184282/21-12-2017?
- 2. What action has been taken so far on the above said letters?
- 3. With respect to CIC letter ref. No. "Appeal No.CIC/DIRED/A/2017/101253 dated 05/07/2018, please provide me following information:
- (i) Has any reply from PIO of Dte of Education been received by CIC?
- (ii) If "yes" for 3(i) then on which date? Pl. provide me photocopy of the reply from Dte of Education.
- (iii) If "No" for 3(i) what action has been initiated by CIC against the PIO(HQ) of Dte. of Education?
- 2. Shri R.P. Grover, CPIO & DO to IC(YA) vide letter dated 03.10.2018 has furnished following information:-
  - "1. Action if any is pending.
  - As above.
  - 3. (i) Yes
    - (ii) 19.7.2018 vide dairy no 145479. Copy of the letter (6 pages) is enclosed.
    - (iv) As per the point no 3 (ii)

- In the appeal, appellant has stated that:-
- "Unsatisfied with the reply of CPIO (IC-YA), I am preferring first appeal on following grounds:-
  - 1. No clear reply for Point no.1 and 2 of my letter have been provided related to action taken on complaints during the period of one year.
  - 2. With respect to point 3(ii) just a formality has been done by the PIO(HQ) of Directorate of Education and the copies of letters totally irrelevant to the information sought by me."

## Decision with reasons:-

- 4. From the above, it is observed that information provided by the CPIO on Points 1 & 2 seems to be inappropriate, therefore, direction is given to Shri R.P. Grover, CPIO & DO to IC(YA) to re-visit the matter and provide appropriate information as sought to the appellant within 2 weeks from the date of receipt of the order. On other points of the RTI application, factual information has been provided by the CPIO, therefore, no intervention is required.
- 5. The appeal is, therefore, disposed of accordingly.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg. Munirka, New Delhi-110067 against this order within 90 days.
