**Brief facts of the case:-**

In the RTI application, appellant has sought following information concerning to case File No.CIC/BS/A/2016/000258 and action taken report on his petitions dated 23.05.2018 and 07.08.2018:-

*(A) CIC order dated 1-5-2017 and 2<sup>nd</sup> Appeal file No.CIC/BS/A/2016/000258*

- (1) How many Respondents are in my 2<sup>nd</sup> Appeal*
- (2) To how many Respondents CIC order dated 1-5-2017 directed file affidavits (copy of order is enclosed)*
- (3) How many Respondents have filed affidavits and how many Respondents have not filed affidavits (From record of case file)*
- (4) From Video Conference feed of above 2<sup>nd</sup> Appeal (if maintained) please find and inform if the CIC had promised to look into the matter after receipt of affidavits from the respondents.*

*(B) From processing record of my prosecution complaint dated 188882017*

- (1) Copy of note sheet by which Prosecution Complaint was placed before CIC for hearing or rejection*

*(C) My Petitions dated 23 May 2018 and 07 Aug 2018 to Prof. M. Sridhar Acharyulu, CIC (Photocopies enclosed)*

- (1) Copy of note sheets by which said petitions were processed for order of CIC justifying rejection of my Prosecution Complaint or restoration of same for hearing by CIC on non-compliance and improper affidavit."*

2. Shri T.K. Mohapatra, CPIO & DR IC(A) vide letter dated 28.09.2018 furnished following information:-

*"A(1) & (2): No information is available other than the order of the Commission in which the respondent names are given.*

*A(3): Please refer the Commission order in which it has been directed to the respondents i.e. Deptt. of Posts, to provide the affidavit and the respondents filed the affidavit. No other information is available with the CPIO*

*B(1): There is no notesheet in the concerned case file.*

*C(1): There is no such notesheet available in the concerned case file.*

**Decision with reasons:-**

On perusal of the RTI application, CPIO's reply and submissions made in the appeal, it is observed that CPIO has provided appropriate and factual information on the basis of record available in the concerned case file. However, since the appellant is not satisfied with the information provided, it may be more appropriate that he may inspect the said case file. **Direction is accordingly given to Shri T.K. Mohapatra, CPIO & DR to IC(SA) to offer inspection of the concerned case file to the appellant within 2 weeks from the date of receipt of the order with mutual convenient date and time.**

4. The appeal is, therefore, disposed of accordingly.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
