Brief facts of the case:-

Please provide me the following informations under RTI Act – 2005:

- 1) Provide me the details of status of my appeal.
- 2) Provide met the details of my appeal number."
- 2. Shri K.A. Talwar, DS & CPIO (CR I) vide letter dated 05.10.2018 forwarded the information u/s 5(4) given by Shri Rabin Kumar, DEO, CR-II, which is as under:-

"With reference to your letter no.CICOM/R/2018/00958/CR-I dated 04.10.2018, it is intimated that after scrutiny of diary no.145955 dated 23.07.2018 by the Compliance Cell it was found that a Second Appeal was already registered against the RTI Application Dated 20.04.2018 of shri Shashank Jadon. Therefore it was linked with the file No.CIC/CBRUI/A/2018/141354 on 26.07.2018 and approved by the DR of concerned registry on 26/07/2018 (copy enclosed)."

- In the appeal, appellant has stated that:-3.
 - "1) That the reply of DS & CPIO, CR-I is ambiguous and he is unable to comprehend the meaning of it.
 - 2) That it is not clear what action was taken regarding my appeal.
 - 3) That it is not clear who will take the action/initiative whether C.I.C or me.
 - 4) That no order has been passed by C.I.C to C.B.I regarding providing me requisite informations w.r.t. my original application to C.B.I.
 - 5) That it has been mentioned in the status that my appeal has been approved. What does that means?
 - 6) In view of above facts and circumstances please clarify the above points as soon as possible."

Decision with reasons:-

- In regard to the query raised in the appeal by the appellant, it is to mention that 2nd Appeal filed by the appellant has been registered on 07.03.2018 vide case file No.CIC/CBRUI/A/2018/141354 and it will be listed for hearing by the concerned registry of the Commission in its own turn. The appeal(s)/complaint(s) are decided on first cum first serve basis in the Commission. Hearing notice will be issued to the appellant by the concerned registry as & when its turn comes up.
 - As regards information furnished by the CPIO is concerned, it is observed that 5. information provided is factual and appropriate.
 - The appeal is, therefore, disposed of accordingly. 6.
 - In case the appellant is aggrieved by the decision, he is free to file second 7. appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
