Brief facts of the case:-

In the RTI application, appellant has sought certified copy of document diarized vide Diary No.635375 dated 13.11.2018 under 'life or liberty of a person' clause.

2. Shri T.K. Mohapatra, CPIO & DO to IC(SA) vide letter dated 16.11.2018 furnished following information:-

"Point no.1: In your RTI application you have mentioned receipt of e-mail from the Commission in respect of submission of a link paper having diary number 635375 dated 13-11-2018 of Sangeet Natak Akademi, New Delhi (without any file number) and uploaded in file number CIC/SANAK/A/2017/178214.

Since this letter is not in original but a copy only, hence there is no question of providing any certified copy of the same in absence of original document. You can approach the concerned public authority i.e. Sangeet Natak Akademy to obtain the certified copy of the letter."

Decision with reasons:-



On perusal of the RTI application, reply of the CPIO, it is observed that custodian of the said letter as per reply of the CPIO is Sangeet Natak Akademy, New Delhi, therefore, direction is given to Shri T.K. Mohapatra, CPIO to transfer the RTI application u/s 6(3) of the RTI Act to the concerned public authority as may be appropriate to that public authority.
