Brief facts of the case:-

In the RTI application, appellant has sought reasons for postponement of 2nd Appeal hearing in case file No.CIC/DRDOR/A/2017/159124/SD from 20:08:2018 to 23:08:2018 and then 23:08:2018 to 18:09:2018. Also sought certified copy of final order dated 18:09:2018 in the aforesaid case file.

- 2. On Points 1 & 2 of the RTI application, Shri H.P. Sen, CPIO vide letter dated 25.10.2018 that "You have not sought any information under Section 2(f) of the RTI Act."
- 3. On Point 3 of the RTI application, CPIO has provided a certified copy of the order dated 18.09.2018.
- 4. Aggrieved with the reply of the CPIO on Points 1 & 2, appellant has filed present appeal.

Decision with reasons:-

5. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that on Points 1 & 2 of the RTI application, appellant has not sought any information but made a query and query does not falls under the definition of 'information' under RTI Act, 2005, therefore, I do not find any infirmity in the response of the CPIO given to the appellant. No further intervention is required on the part of the FAA, in the matter.

- The appeal is, therefore, disposed of accordingly. 6.
- In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
