## Decision with reasons:-

Sen, CPIO & DO to IC(DP) to search the aforementioned documents thoroughly by taking assistance from all concerned officer/section and provide information accordingly to the appellant within 3 weeks from the date of receipt of the order.
- 4. The appeal is, therefore, disposed of accordingly.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
