**Brief facts of the case:-**

In the RTI application, appellant has sought following information:-

*"a) Kindly let me know the charges for information for **one page of A4 size (copied)** to be provided to RTI applicant. Also provide me the ruling and/or circular for the same.*

*b) Whether charges for information for **one page of A4 size (copied)** to be provided to RTI applicant, shall be waived or not to be charged. Provide me the ruling and/or circular for the same.*

*c) **Upto how many pages of A4 size (copied)**, information should be provided free of cost to the RTI applicant. Provide me the ruling and/or circular for the same."*

2. Shri TBJs Rajappa, CPIO, RTI Cell vide letter dated 05.11.2018 informed the appellant that "No other information is available with the CPIO, CIC other than that is available in RTI Act, 2005 & RTI Rules 2012 which are already available in public domain."


**Decision with reasons:-**

3. On perusal of the RTI application, CPIO's reply and appeal, it is observed that the CPIO has also provided link of the RTI Rules 2012 where desired information is available. Hence, there is no infirmity in the reply of the CPIO. No further intervention is required on the part of the FAA, in the matter.

4. The appeal is, therefore, disposed of accordingly.


5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
