## Decision with reasons:-

As per appeal, appellant is aggrieved with the reply of CPIO on Point-6 of the RTI application only.

- On Point-6, appellant has sought following information:-2.
  - "Certified Copy of the Letter dated 19.11.2018 addressed to the Hon'ble Commission, Prof. (Dr) M. Sridhar Acharyulu of the Central Information Commission (CIC) by Smt. Vinodi Sharma, CPIO - Sangeet Natak Akademi (SAN) seeking 'Copy of the letter dated 13.11.2018 which was uploaded vide Diary No.635375 vide which I was declared Dead."
- Shri T.K. Mohapatra, CPIO vide letter dated 04.12.2018 has responded that:-3.
  - ".....Since, the letter is an uploaded document in the Commission's website, it is not possible to provide the certified copy of the same in absence of the original letter."
- After perusal of the appeal, the matter has been enquired with Shri T.K. 4. Mohapatra, CPIO who informed that he misunderstood the Point 6 of the RTI application and replied about the letter dated 13.11.2018 that it was an uploaded document. Moreover, appellant sought certified copy of letter dated 19.11.2018 submitted by Smt. Vinodi Sharma, CPIO, Sangeet Natak Akademi, which also cannot be provided as the Commission is not the originator of the said letter. Therefore, Point-6 was transferred u/s 6(3) of the RTI Act to the concerned CPIO.

- 5. In view of the above, appellant is advised to approach the concerned public authority to get the desired document.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
