Brief facts of the case:-

In the RTI application, appellant has sought documents of case file No.CIC/POSTS/A/2018/110581.

- 2. Shri T.K. Mohapatra, CPIO to ex.IC(SA) vide letter dated 29.10.2018 has demanded further fee of Rs.316 as photocopy of charges of 158 pages through Demand Draft, Postal Order or Bankers Cheque in favour of PAO, CAT, New Delhi.
- 3. In the appeal, appellant has stated that he has paid the further fee of Rs.316 through e-MO No.081091181108012634 dated 08.11.2018 and as per its tracking record, it is showing paid at JNU 110067.

Decision with reasons:-

4. From the above, it is observed that the appellant has sent further fee of Rs.316/through e-MO, which is not a proper mode of payment and also not received in the
Commission. The CPIO had advised the appellant to make payment through Demand
Draft, Postal Order or Bankers Cheque. However, the matter has been enquired from
PAO, CAT who informed that an amount of Rs.316/- through e-MO was received by
them on 09.11.2018. A copy of acknowledgement receipt dated 09.11.2018 has also

been provided by PAO, CAT. Since, further fee as demanded has been received by PAO, CAT, direction is hereby given to Shri T.K. Mohapatra, CPIO to provide the desired copies to the appellant within 1 week from the date of receipt of the order.

- The appellant is advised that henceforth payment be made with proper mode 5. only, as advised by the CPIO.
- The appeal is, therefore, disposed of accordingly. 6.
- In case the appellant is aggrieved by the decision, he is free to file second 7. appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
