In the appeal, the appellant has requested to conduct first appeal through audio conferencing. Accordingly, the appellant was given an opportunity to represent his case through audio conferencing on 16.03.2018 at 1115 hrs. The appellant was present through audio-conferencing. Shri T.K. Mohapatra, CPIO cum DO to IC(SA) and Shri Ashok Kr. Sharma, CPIO, RTI Cell were present during the hearing. In the RTI application, the appellant has sought 8 points information in respect of case file No.CIC/NYUKS/C/2017/168343.

Decision with reasons:-

2. During the hearing, the appellant has stated that in a CIC's decision No.CIC/NYUKS/C/2017/168343, Commission has warned him not to file any RTI application on the subject matter, if he files, same will be rejected in public interest to pursue the prescribed objective of the RTI Act. In this regards, on points 1 to 3 of the RTI application, he sought specific rules/act/circular/guidelines/ law etc under which the Information Commissioner can caution/warn the RTI applicant, which has not been provided by the CPIO. The CPIO, Shri T.K. Mohapatra has that no other documents except that are available under RTI Act, 2005 and RTI Rules 2012 is available. The CPIO can provide only that information, which is available on his record. Since factual information has been provided by the CPIO, no further intervention is required on the part of the FAA, in the matter.

3. No other points has been raised by the appellant, during the hearing, the appeal is, therefore, disposed off.




