The hearing was scheduled on 06.08.2018 in consultation with the appellant but the appellant requested through email dated 06.08.2018 that he will be available on mobile.

2. Accordingly, appellant was heard over phone when Shri Ashok Kumar Sharma, CPIO, RTI Cell was present. Shri Jeewan Chandra, CPIO(MR) was absent during the hearing despite of hearing notice issued to him.

3. During the tele hearing, appellant asked to FAA to tell him that on which points of his submission, he is disagreeing so that he can argue. He was informed that in the hearing process, the appellant is given an opportunity to present his case for better appreciation. It is not for the argument between appellant and FAA to decide the case.

Brief facts of the case:-

4. In the RTI application, appellant has sought following information:-

"1. Provide the Website links of all the past FAA Shri Tarun Kumar Decisions in the case of Mr. CJ Karira Vs Central Information Commission.

2. If, Website links not working then provide copies vide other mode of communication along with expected date by which the Website links will be working.

P.T.O.

3. Name, Designation and Email Address of the official accountable for Website links not working."

Shri Jeewan Chandra, CPIO(MR) vide letter dated 26.06.2018 replied as under:-

"With reference to RTI application Regn. No.-CICOM/R/2018/50391 dt. 30.05.2018, it is informed that the Commission has already taken up the matter with the NIC authority for disclosure/uploading of FAA order and RTI replies on the Commission website under link dsscic.nic.in/rti-request/appeal with NIC Wherein they have been requested to get the matter resolved in consultation with DoPT. This has been requested in case of Shri R.K. Jain RTI application. The photocopies of letters written to NIC are enclosed for your information."

5. On the grounds of appeal, appellant has stated that PIO obstructed the information by not providing point-wise reply and demanded information must be provided.

Decision with reasons:-

6. On perusal of the case file, it is observed that CPIO has provided factual information in respect of Point-1 of the RTI Application but CPIO has not provided information on Points 2 & 3 of the RTI application. Direction is accordingly given to Shri Jeewan Chandra, CPIO(MR) to provide appropriate information on Points 2 & 3 to the appellant within 1 week from the date of receipt of the order.

7. The appeal is, therefore, disposed off accordingly.

8. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
