## Record of proceedings

The matter was fixed today at 11:00 a.m. and opportunities were afforded to both the parties to present their case. Sh. Ashok Kumar Sharma, CPIO (RTI Cell) and Sh. Mahesh Rawat, PA to Addl. Secy appeard on behalf of the Respondent but none appeared on behalf of the Appellant in the matter till 3:00 p.m.

## Brief facts of the Case:

Sh. Varun Krishna has filed an online First Appeal on 24.07.2018 against the reply of Sh. Mahesh Rawat, in response to the RTI application dated 13.07.2018 filed by Sh. Varun Krishna. The Appellant filed his First Appeal on the ground that information sought for in respect of point 1,2,3 and 4 of his RTI application was obstructed and sought for the relief of providing the information and also a personal hearing in the interest of natural justice.

I have gone through the RTI application filed by Sh. Varun Krishna as well as the reply in respect of the said RTI application sent by Sh. Mahesh Rawat as the deemed CPIO and found that the CPIO has replied properly to the RTI application filed by the Appellant. It is also a fact that as per RTI Act, 2005, the information available with the CPIO is to be provided and he is not required to generate the information as demanded by the Applicant/Appellant if the same is not maintained or available with the CPIO. Hence, the First Appeal made by Sh. Varun Krishna is devoid of merits and the same is dismissed.



Sh. Varun Krishna is further informed that he is free to file a Second Appeal under Section 19 (1) of the RTI Act, 2005 before the Central Information Commission at the above mentioned address within a period of 90 days from the date of receipt of this order.
