Appellant was heard over phone when Shri S.C. Sharma, CPIO & DO to Chief IC was also present.

Brief facts of the case:-

2. In the RTI application, appellant has enclosed a letter dated 05.06.2018 sent to Dy. Registrar of CIC and sought following information :-

- "1. Names and Designations of the officials who dealt with it, and dates of movement o the letter*
- 2. Provide certified copies of all the letters, note sheets and any other document put up to various officials, including all notings thereupon*
- 3. Provide a certified copy of document/s containing procedure for approaching the commission for re-hearing of an appeal/complaint under section 12 of the Right to Information Rules, 2012*
- 4. Provide a certified copy of the record/s marking the attendance of various parties who were present during the hearings conducted by CIC Shri R K Mathur on 31/05/2018"*

3. Shri S.C. Sharma, CPIO & DO to Chief IC vide letter dated 23.08.2018 replied as under:-

"Please refer to your RTI application dated 05.06.2018 received in this Registry through RTI Cell of CIC on 18.08.2018. Information is as under please:-

- 1. On perusal of your above RTI application, it is seen that no specific information has been asked for. However, on perusal of record, it is seen that all the six cases were heard on 22.03.2018 and again on 31.05.2018 and copies of the decisions in these cases have already been provided to you."*

Decision with reasons:-

4. During the hearing, appellant stated that CPIO has denied the information sought for by wrongly claiming that no specific information has been sought though the information sought for is very specific. He requested to direct the CPIO to provide point-wise information.

5. On perusal of reply of the CPIO, Shri Sharma, it is seems that he has mistakenly treated the letter dated 05.06.2018 enclosed with RTI application dated 18.08.2018 as RTI request and furnished reply accordingly. Shri S.C. Sharma present during the hearing accepted the mistake and stated that it was happened inadvertently and regretted for the same. **Direction is, therefore, given to Shri S.C. Sharma, CPIO & DO to Chief IC to furnish point-wise appropriate information as sought in the RTI application dated 18.08.2018 to the appellant within 1 week from the date of receipt of the order.**

6. The appeal is, therefore, disposed off accordingly.

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
