Appellant along with Advocate Narvinder Thakran was present. Shri Krishan Avtar Talwar, CPIO cum DR to CR-I, Mrs. Savita Taluja, CPIO cum SO(Admn) and Shri TBJs Rajappa, CPIO, RTI Cell were present during the hearing.

Decision with reasons:-

During the hearing, appellant has stated that Point-4 of the RTI application has already been covered in his appeal No.CICOM/A/2018/60171, therefore, this point is not pressed. Information on Point-7 has not been provided regarding acknowledgement for emails. On perusal of the case file, it is observed that on Point-7, Shri TBJs Rajappa, CPIO, RTI Cell has forwarded a reply dated 24.09.2018 furnished by Shri R.K. Arora, PPS to ex. Chief IC. In the reply Shri R.K. Arora has stated that "Yes, the e-mails have been received and filed for no action." Hence, the deemed CPIO has provided factual information to the appellant, therefore, no intervention is required on the part of the FAA.

2. After the hearing, appellant has sent an email and sought copies of the written briefs submitted by the CPIOs. In this regard, it is to state that no written briefs have been submitted by any of the CPIO to the FAA.
