Appellant along with Shri Narvinder Thakran, Advocate was present. Shri S.K. Rabbani, DS(GA), Shri Krishan Avtar Talwar, CPIO cum DR to CR-I, Shri Jeewan Chandra, CPIO(MR) and Shri TBS Rajappa, CPIO, RTI Cell were present during the hearing. Shri S.C. Sharma, CPIO verbally informed in advance that due to sudden death in his relation, he would not be available during hearing.

**Decision with reasons:-**

2. During the hearing appellant has stated that he is aggrieved with reply of CPIOs on Points 5,6, 7,8,9,10,15,16 and 17 of the RTI application.

3. On Point 5, appellant stated that deemed CPIO, Shri R.K. Arora, PPS to CIC in his reply informed that the e-mails mentioned at Points 2, 3 & 4 have been received and filed for no action. Whether these emails filed without any remarks or there are remarks that no action is required, filed it. **Direction, in this regard, is given to Shri R.K. Arora, PPS to check said emails and intimate, if any remarks are given or not on the said emails to the appellant within 01 week from the date of receipt of the order.**

4. On Point-6, appellant has stated during the hearing that CPIO has allowed inspection of case file but he has not given his contact number and email I/D. On perusal of the CPIO's reply, it is observed that CPIO has provided his contact number and also offered inspection on any working day with prior intimation and consent regarding date and time. Therefore, there is no infirmity in the reply of the CPIO. **However, Shri S.C. Sharma, CPIO is advised to provide his email I/D also.**

5. As regards Points 7, 8 & 9, the matter has been enquired from Shri S.C. Sharma, CPIO who informed that Shri Prem Kumar, Legal Consultant (LC) has uploaded the adjunct order on 11.10.2018 and he approved it on 15.10.2018 as there was Annual Convention of the Commission 12.10.2018 and 13 & 14.10.2018 were holidays being Saturday & Sunday. Therefore, the software system sent sms to the appellant on 15.10.2018. The software system always shows the initial date of uploading of the orders and it never shows the date of approval of the DRs/DOs.

6. On Point 10, the appellant has stated that the reply is not properly worded. However, reply is found to be appropriate.

7. Replies furnished on Points 16 & 17 by CPIO(MR) are not found appropriate. **Direction is accordingly given to Shri Jeewan Chandra, CPIO(MR) to re-visit the matter and provide appropriate reply to the appellant within 1 week from the date of receipt of the order.**


8. On Point-15, the appellant has stated that Shri S.C. Sharma, CPIO has furnished information about Chief IC registry but he has not provided information of other registries. In this regard, it is clarified that cause list pertaining to hearing of CICs are available on CIC's website and appellant may access the cause list to get the information.

9. The appeal is, therefore, disposed off accordingly.

10. In case the appellant is aggrieved by the decision, he is free to file second

appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
