**Brief facts of the case:-**

2. In the RTI application, appellant has sought following information:-

*"Kindly provide copy of report of Advisor, to Administer of Chandigarh, against F.No.CIC/UTOCH/A/2017/141124/SD. Kindly, treat this information sought is on a serious matter and is in public interest, hence it may not be denied by applying provisions of Section 8 of RTI Act 2005. Further, what action is proposed to be taken in this regard may also be informed."*

3. Shri H.P. Sen, CPIO & DO to IC(DP) vide letter dated 29.11.2018 has replied as under:-

*"With reference to your RTI application, it may be mentioned that the information sought can not be provided as it pertains to third party and rejected under Section 8(1)(j)."*

**Decision with reasons:-**

4. During the hearing, appellant has reiterated the contents of his appeal. He further stated that third party can be an individual but not an institution.

5. After hearing the submission of the appellant, FAA is of the considered view that information sought by the appellant does not attract Section 8(1)(j). Hence, direction is




