On the request of the appellant, he was heard over phone. Shri H.P. Sen, CPIO & DO to IC(DP) was present during the hearing.

Brief facts of the case:-

2. In the RTI application, appellant has stated as under:-

"One Email was sent to Shri R.K. Mathur Honorable Chief Information Commissioner on 21.02.2018 on the subject-Fax sent is not confirmed, hence this Email on the subject as mentioned in the letter being attached, vide which a letter dated 21.02.2018 was attached with a request to communicate on the request to reconsider the Commission decision as communicated vide letter dated 16.02.2018 in the light of details submitted at para 2.0 to 6.0, otherwise undersigned had no option but to contact the judiciary and in that case entire cost is to be borne by the Commission. Since, more than one month has already passed, documents in support of any decision taken on reconsidering the matter as communicated vide JS(Legal) letter dated 16.02.2018 in terms of letter dated 21.02.2018 may be supplied. Alternatively, if no action is taken, reasons for not taking action may also be informed."

3. Shri H.P. Sen, CPIO & DO to IC(DP) vide letter dated 11.05.2018 has replied as under:-

".....it may be mentioned that this Registry has no information about the E.Mail/Fax sent to the Hon'ble CIC, Shri R.K. Mathur requesting to reconsider the decision as communicated earlier in terms of letter dated 21.02.2018. No reason is, therefore, available for not taking action in the matter."

Decision with reasons:-

4. During the hearing, appellant has reiterated the contents of his appeal.

5. Since email dated 21.02.2018 was sent to the former Chief Information Commissioner, Shri R.K. Mathur, **direction is given to Shri H.P. Sen, CPIO & DO to IC(DP) to take assistance u/s 5(4) of the RTI Act from PS to former Chief IC and inform the appellant, if any action taken on it or not and the reason thereof (if available) to the appellant within 2 weeks from the date of receipt of the order.**

6. The appeal is, therefore, disposed off accordingly.

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
