In the RTI application, appellant has sought status of action taken on his letter dated 30.07.2018 against case No.CIC/EPFOG/A/2018/0114360.

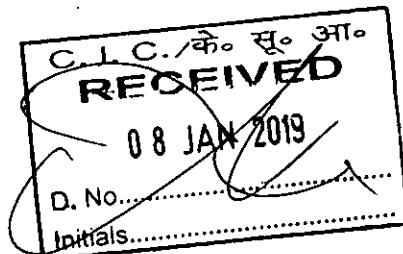
2. Shri T.K. Mohapatra, CPIO vide letter dated 26.10.2018 has responded that:-

No action has been taken by the Hon'ble Information Commissioner as per the information available in the case file other than the corrigendum order dated 25-07-2018."

Decision with reasons:-

On perusal of the appeal and its enclosures, it is observed that appellant is not aggrieved with the reply of the CPIO, CIC but it seems that he is aggrieved with the non-compliance of the order of the Commission in the above mentioned case. In this regard, it is to mention that if appellant so desires, he may file non-compliance case against the concerned public authority in the Commission, as per order No.11/JS(Law)/2016/CIC dated 29th November, 2016 enclosed herewith.
