Appellant was present. Shri T.K. Mohapatra, Director cum CPIO and Shri TBJS Rajappa, CPIO, RTI Cell were present.

Decision with reasons:-

2. During the hearing, appellant has stated that he is aggrieved with the response of CPIO on Points 9,11,12 & 13 of the RTI application. In the RTI application, he has sought certified copy of explanation received by the Commission, before 16.11.2018 or on 16.11.218 from Ms. Vinodi Sharma, respondent CPIO. Sangeet Natak Akademi during hearing held on 05.11.2018 in case F.Nos. CIC/SANAK/A/2018/117881, CIC/SANAK/A/2018/ 117888, CIC/SANAK/A/2018/127290 and CIC/SANAK/A/2018/ 143174. But CPIO, Shri T.K. Mohapatra replied that "No such copy is available in the e-book of case file." The reply given by the CPIO is not correct as he sought same information from respondent CPIO, Sangeet Natak Akademi who provided copy of explanation in each case sent by her through email on dated 16.11.2018 to the email I/D registryicsa@gmail.com.

Shri T.K. Mohapatra, CPIO has submitted that appellant has not mentioned about any email in the RTI application and only sought copy of explanation and as there

was no such letter in the e-book, he has replied accordingly. He has no intention of denial of any information to the appellant.

- 3. Since the public authority in this case has now been allocated to the registry of IC(VN), direction is accordingly given to Shri Ashok Kumar Assija, CPIO & DO to IC(VN) to go through aforementioned case files and provide certified copy (as per DoPT OM No.10/1/2013-IR dated 06.10.2015) of emails dated 16.11.2018 vide which explanations were sent to the Commission (if available) to the appellant within 2 weeks from the date of receipt of the order.
- 4. The appeal is, therefore, disposed of.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
