Decision with reasons:-

2. As per appeal, appellant is aggrieved with the response of CPIO on Points 3 & 4 and non-receipt of information on Points 1 & 2 of the RTI application.
3. On perusal of the concerned case file of RTI Cell, it is found that Point 1 of the RTI application was transferred online to the CPIO, Ministry of Parliamentary Affairs on 18.12.2018. Hence, appellant is advised to file first appeal against non-receipt of information in the concerned public authority.
4. Mrs. Savita Taluja, SO(Admn) & CPIO vide her letter dated 15.01.2019 has furnished information on Point 2, **which is enclosed herewith.**
5. On perusal of Shri S.C. Sharma, CPIO reply dated 21.12.2018 on Points 3 & 4, it is observed that factual information has been provided by him, therefore, no further intervention is required on the part of the FAA, in the matter.
