In the RTI application, appellant has sought following information:-

"1) The information provided by any PIO nominated under RTI Act-2005 and received by applicant, whether such supplied information is to be treated as valid information of otherwise to produce before CVC, Hon. Court of Law and any other authority established under the Act of parliament. Please provide me copy of Ruling/ Guidelines of commission.

- 2) Please give me the copy of rules framed in the CIC regarding preservation period of concerned case file, in which CIC has given order after hearing.
- 3) Please go through the copy of notice of hearing issued vide letter File No.CIC/ CRAIL/A/2017/117916 dated 28.05.2018 (copy enclosed along with speed post receipt as Doc-1 page 3 to 7) in which hearing held on 25.06.2018 and order issued later on in the case on 28.06.2018 and provide me the copy received from Railway authority for action taken against the responsible officer on the order issued by CIC. Also provide me the COPY OF SERIOUS WARNING issued as per order of CIC.
- 4) Please to through the II nd stage appeal in diary No.113317/2017 dated 15.03.2017 (Copy enclosed along with speed post receipt as Doc.2 page 8 to 35) and inform me when hearing in this case scheduled and when the case will be finalize as it is related to irregular GAZZETTED SERVICE selection in which irregularity established but related documents are not being provided.

- 5) Please go through my application dated 10.08.2018 in the diary no.145107/2018 dated 27.07.2018 (Copy enclosed along with speed post receipt as Doc.3 page 36 to 69) in this case any advisory notice has been issued and when case will be scheduled for hearing as this is very serious case and to ensure TRANSPARANCY IN THE GOVT case may please be scheduled on urgent basis. It is very much needed early action as related to the IRREGULAR selection in GAZZETTED SERVICE.
- 6) Please go through the II nd stage appeal dated 15.12.2017 in appeal No CIC/ VS/A/2015/000688 dated 26.09.2018 (Copy enclosed along with speed post receipt as Doc.4) and provide me following information.
 - (a) On RTI application any nominated PIO under RTI Act-2005 PROVIDES manipulated information and if so, is it to be treated as compliance of the concerned application. In the instant case it is brought to the notice of commission that, concerned PIO has supplied manipulated information which attracts violation of ipc-364 (1). In this case whether advisory notice is issued to Railway Board. If issued please provide me the copy of the same.
 - (b) Please provide me the action taken report in this case.
 - (c) The date when this case is scheduled for hearing."
- 2. Shri A.K. Talapatra, ex. DO to ex. CIC(AB) vide letter dated 11.12.2018 has furnished following information:-
 - Point no.1 No such rule/guideline available.
 - Point no.2 Copy of the office order dated 20.07.2016 is enclosed herewith as Annexure-A.
 - Point no.3 Copy as received from the railway department are enclosed as Annexure B (1 and 2).
 - Point no.4 Status report of dak no.113317 as available in computerized management system of the commission is enclosed for your information as Annexure C (1 and 2).
 - Point no.5 Status report of dak no.145107 as available in computerized management system of the commission is enclosed for your information as Annexure D(1 and 2).
 - Point no.6 (a) No such record available.
 - (b) Same as (a) above.
 - (c) Not scheduled for hearing.

Decision with reasons:-

- 3. On perusal of the RTI application, CPIO's reply and submission made in the appeal, it is observed that point-wise factual and appropriate information has been provided by the CPIO.
- 4. However, on Point 4 of the RTI application, appellant has stated that he has resubmitted the appeal on 12.04.2017 after attending deficiencies as mentioned in FM dated 15.03.2017 of Dy.No.113317/2017. Similarly, appellant has also re-submitted his complaint returned vide FM dated Nil of Dy.No.145107/2018. Direction in this regard is given to Shri Krishan Avtar Talwar, CPIO & DR to CR-1 to provide status of resubmitted appeals/complaints of the appellant within 2 weeks to the appellant from the date of receipt of the order.
- 5. The appeal is, therefore, disposed of.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
