

Brief facts of the case:-

In the RTI application, appellant has sought following information -

- 11- On which basis/grounds my Early Hearing application/recuest of 2nd Appeal (no 146793 dt 25/7/2018 & no 147398 dt 30/7/2018 was rejected as informed by Dy registrar S.C. Sharma on dt 19/9/2018, through e-mail inshtryalar tacongress@gmail.com against Mr. Rahul Gandhi & Mrs Sonia Gandhi?
- 2. I submitted ground "citizens of India must know the correct details of their leaders/Lawmakers/MPs well before Loksabha elections 2019 which are very nearby so citizens of India could make their opinion to cast votes to strengthen the DEMOCRACY." Is it not a sufficient legal valid ground for Early Hearing which is a legal provision in CIC?

I m not alleging Mr Rahul Gandhi, only asking "How mar.) passports have been issued by any Government in the world to him or alias, if any, bearing his photograph, who is Member of Parliament/public authority/Indian citizer, there can which ground/basis CIC is not taking this issue Most Seriously & urgently to strengthen Democracy, while UPA govt itself make RTI Act 2005 and hence CIC??
