**Brief facts of the case:-**

In the RTI application, appellant has stated as under:-

"SIR I WOULD LIKE TO KNOW THE STATUS OF CASE NO CIC/RM/A/2012/001012.  
CASE IS FILED BY MR P VASU AGAINST THE LAWRENCE SCHOOL LOVEDALE.

LAWRENCE SCHOOL LOVEDALE ARE NOT THE APPELLANT IN THE ABOVE SAID  
CASE BUT THEY HAVE REPLIED THAT THEY ARE THE APPELLANT IN THE  
ABOVE SAID CASE IN A REPLY SENT TO MY RTI APPLICATION SENT TO THEM  
ON 24<sup>TH</sup> AUG 2018.

THEY HAVE CLAIMED THAT SINCE THE ABOVE SAID CASE IS PENDING THEY  
CANNOT FURNISH THE REQUIRED INFORMATION UNTIL THE CASE IS  
DISPOSED.

I WOULD LIKE TO KNOW WHAT ARE THE DOCUMENTS SUBMITTED BY  
LAWRENCE SCHOOL LOVEDALE & THE DEPT OF SCHOOL EDUCATION &  
LITERACY UNDER MHRD AS ORDERED BY HGNARABLE CIC IN ONE OF THE  
HEARINGS.

DATE OF SUBMISSION OF DOCUMENTS BY SCHOOL AND MHRD.

REASON FOR DELAY IN ORDERS IN THIS CASE.

2) I HAD SENT AN COMPLAINT TO SHRI BIMAL JULKA REGARDING LAWRENCE  
SCHOOL LOVEDALE ON 25/9/18. I WOULD LIKE TO KNOW THE STATUS OF MY  
COMPLAINT. POSTAL TRACKING ID NO 6984671458835

SINCE LAWRENCE SCHOOL LOVEDALE HAS NOT COMPLIED TO MHRD ORDER EVEN IN SPITE OF REMINDERS SENT TO THEM I KINDLY REQUEST YOU TO GIVE ME THESE INFORMATION IN ORDER TO PROCEED AS PER LAW IN IMPLEMENTING RTI TO LAWRENCY SCHOOL LOVEDALE.

HAS THE CENTRAL INFORMATION COMMISSION CONSIDERED THE ORDER GIVEN IN LAWRENCE SCHOOL SANAWAR CASE ON 25/1/2008 IN THIS CASE."

2. Shri K.L. Das, CPIO & DO to IC(BJ) vide letter dated 31.12.2018 replied as under:-

".....The case against Lawrence School was last heard in the Commission on 14.03.2017. The Commission directed the School and MHRD to submit their written submissions for further hearing of the case but nothing appears to have been received from any of them. No hearing took place thereafter. The original file is not available. No reason is available in the digitized copy of the file downloaded from the Commission's website.

2. Your letter dated 25.09 2018 has not been received in this Registry so far."

**Decision with reasons:-**

3. On perusal of the RTI application, CPIO's reply and submissions made in the appeal, it is observed that CPIO has not provided complete information and wrong date of hearing, direction is accordingly given to Shri K.L. Das, CPIO & DO to IC(BJ) to re-visit the matter and provide complete and appropriate information to the appellant within 2 weeks from the date of receipt of the order.

4. ✓ The appeal is, therefore, disposed of. DD No.326876 dated 18.12.2019 for Rs.10/- is returned herewith, as no fee is required for filing appeal in the Commission.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
