**Decision with reasons:-**

In the appeal, appellant has stated that why Dak Section forwarded RTI application after two days of receipt? Why CPIO, RTI Cell forwarded RTI application to concerned CPIOs after two days of receipt? Why CPIO, RTI Cell intimated appellant about transfer of RTI application after 6 days? In this regard, it is to mention that as per RTI Act, 2005, information is to be provided within 30 days from the date of receipt of the RTI application and in this case all concerned CPIOs had provided information within prescribed period so the questions raised by the appellant does not arise.

2. On Points 1 & 2, appellant stated that "...the 'Appellant' is aggrieved with 'Reply' of 'Ld. CPIO'. The 'Ld. CPIO' provided 'Copies of Minutes Intimation Circular/Notice etc.' which was routed in the Central Information Commission (CIC)." In this regard, direction is given to Shri Sushil Kumar, CPIO & DS(Admn) to re-visit the matter and copy of agenda items as sought on these two points, if available, be provided to the appellant within 2 weeks from the date of receipt of the order.

3. On Point 4 of the RTI application, appellant stated that he sought certified copy of the document but CPIO provided uncertified copy of the desired document. **Direction,**



in this regard is given to Shri Ashok Kumar Assija, CPIO & DO to IC(VN) as the public authority of the case is presently allocated to the registry of IC(VN) to provide certified copy of the desired document to the appellant as per DoPT OM No.10/1/2013-IR dated 06.10.2015 within 1 week from the date of receipt of the order.

4. The appeal is, therefore, disposed of.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
