Brief facts of the case:-

2. *Please provide 'Certified Copy' of the 'Print-Out Page' whereby above-mentioned Internet Protocol (IP) Address mentioned as per **clause (ii) & (iii) of sub-section (j) of Section (2) of the RTI Act, 2005.***

2. Shri Jeewan Chandra, CPIO(MR) vide letter dated 23.01.2019 responded that:-

"Point 1: Desired information may not provide.

Point 2: Not applicable, as per reply given for point No.1."

Decision with reasons:-



On perusal of the RTI application, CPIO's reply and appeal, it is observed that the CPIO has supplied incomplete information. **Direction is, therefore, given to Shri Jeewan Chandra, CPIO(MR) to re-visit the matter and provide appropriate complete information to the appellant within 1 week from the date of receipt of the order.**
