Brief facts of the Case:-

Shri T.K. Mohapatra, CPIO had sought further fee Rs.22/- and Rs.14/- (Total Rs.36/-) for providing copy of the documents as sought on Points 1 and 5 of the RTI application. The appellant deposited Rs.40/- through e-IPOs and requested to return balance amount of Rs.4/-. Shri T.B.S. Rajappa, CPIO, RTI Cell vide letter dated 11.01.2019 returned the e-IPOs with the remarks that the required payment of Rs.36/- may be sent for necessary action as there is no provision to return balance amount of Rs.04/-.

Decision with reasons:-

On perusal of the RTI application, CPIO's reply and submissions made in the appeal, it is observed that CPIO as well as appellant both are right on their part. However, in the spirit of the RTI Act, **direction is given to Shri Ashok Kumar Assija, CPIO & DO to IC(VN) as the public authority of the cases are presently allocated to the registry of IC(VN) to provide certified copy as per DoPT OM No.10/1/2013-IR dated 06.10.2015 of the desired documents free of charge to the appellant within 2 weeks from the date of receipt of the order.**


4. The appeal is, therefore, disposed of.
